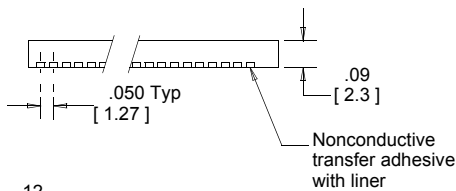
Contact Detail



Recommended Board Layout

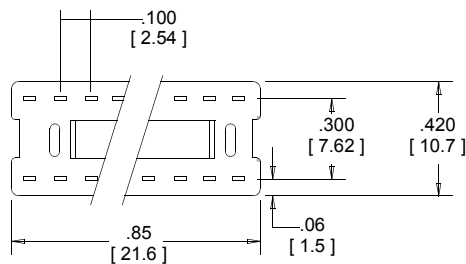
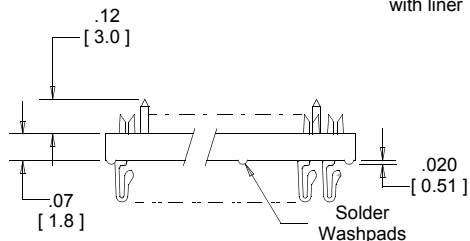


Connector Cover



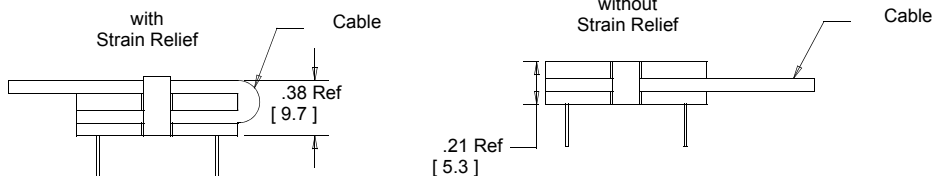
"U" Contact 16X
