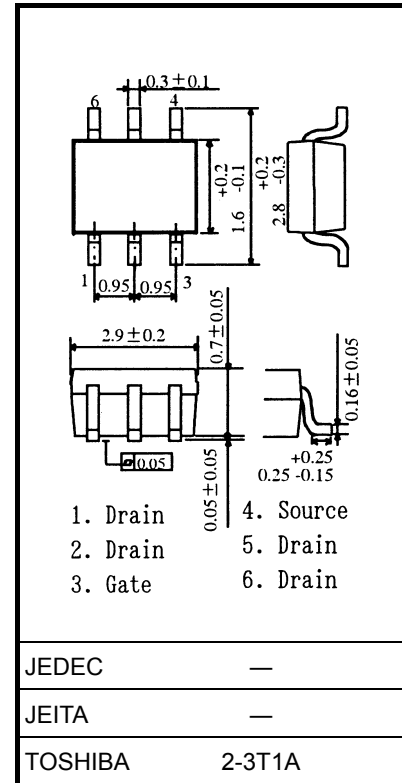

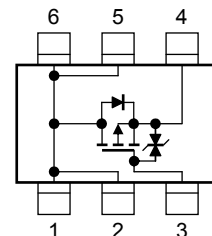

## Circuit Configuration



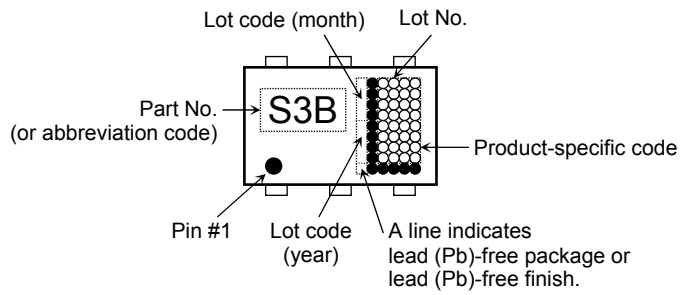
