

Low voltage fast-switching NPN power transistor

The device in a NPN transistor manufactured using new "PB-HCD" (Power Bipolar High Current Density) technology. The resulting transistor shows exceptional high gain performances coupled with very low saturation voltage.




Figure 1. Internal schematic diagram



Figure 2. DC current gain (@ V_{CE}=1 V) Figure 3. DC current gain (@ V_{CE}=2 V)




Figure 4. Base-emitter on voltage

Figure 5. Base-emitter saturation voltage






Figure 6. Collector-emitter saturation voltage

Figure 8. Resistive load switching time Figure 9. Resistive load switching time




3 Package mechanical data
