




Fig. 1 - Forward Voltage vs. Forward Current




Fig. 2 - Normalized Non-Saturated and Saturated CTR vs. LED Current




Fig. 3 - Normalized Non-Saturated and Saturated CTR vs. LED Current





Fig. 4 - Normalized Non-Saturated and Saturated CTR vs. LED Current






Fig. 6 - Collector Emitter Current vs. Temperature and LED Current




Fig. 7 - Collector Emitter Leakage Current vs.Temperature




Fig. 8 - Propagation Delay vs. Collector Load Resistor





Fig. 9 - Switching Timing


Fig. 10 - Switching Schematic


