





Figure 1. Test circuit for dV/dt<sub>cr</sub> and dV/dt<sub>crq</sub>




Figure 3. Motor control circuit




Figure 4. Derating diagram




Figure 5. Test pulse diagram for sample test according to DIN EN 60747-5-2(VDE0884)/ DIN EN 60747-; IEC60747




Figure 6. Total Power Dissipation vs. Ambient Temperature




Figure 9. Relative On - State vs. Ambient Temperature




Figure 7. Forward Current vs. Forward Voltage




Figure 10. Off - State Current vs. Ambient Temperature




Figure 8. Relative Threshold Forward Current vs. Ambient Temperature





Figure 11. On - State Current vs. Ambient Temperature






Figure 12. On - State Current vs. Ambient Temperature


