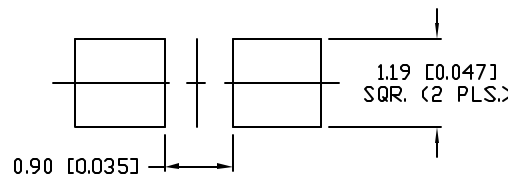


LEAD FREE REFLOW PROFILE
