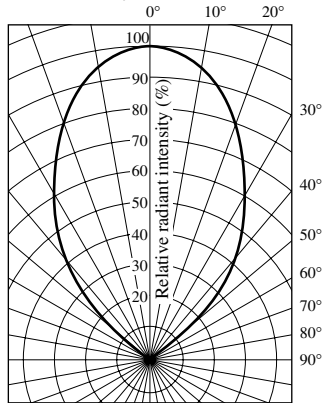

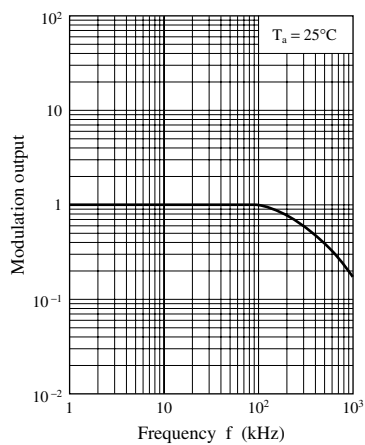
Spectral characteristics
