




## Package Dimensions, QSB34GR

Fig. 1 Relative Spectral Sensitivity vs. Wavelength




Fig. 2 Short Circuit Current vs. Irradiance




Fig. 3 Capacitance vs. Reverse Voltage




Fig. 4 Dark Current vs. Temperature




Fig. 5 Dark Current vs. Reverse Voltage







Fig. 6 Response Time vs. Load Resistance




## **Recommend IR Reflow Soldering Profile**


