




# Forward Current vs. Collector Dissipation Temperature Rating




## Forward Current vs. Forward Voltage Characteristics (Typical)




# LED Current vs. Supply Voltage (Typical)




## LED Current vs. Ambient Temperature Characteristics (Typical)




Low-level Output Voltage vs. Output Current (Typical)




Low-level Output Voltage vs. Ambient Temperature Characteristic (Typical)




## Current Consumption vs. Supply Voltage (Typical)
