

# Instructions and Parts List

## Scotch™ BRAND H-131 One-Hand Filament Tape Applicator Model 27300

**Description:** The H-131 One-Hand Filament Tape Applicator is designed primarily for "L" clip and "C" clip tape applications for closing and reinforcing boxes with "Scotch" brand Filament Tape. The use of this applicator provides a quick and easy one-hand method to apply, cut and buff tape clips with 2 inch [50 mm] minimum leg lengths.

### Specifications

**Tape:** "Scotch" brand Pressure-sensitive Filament Tape No. 898 — 60 yds. or 55 m

**Tape Width:** 3/4 inch or 18 mm maximum  
3/8 inch or 9 mm minimum

**Tape Roll Diameter:** 5-1/2 inches [140 mm] maximum  
on a 3 inch [76.2 mm] diameter core

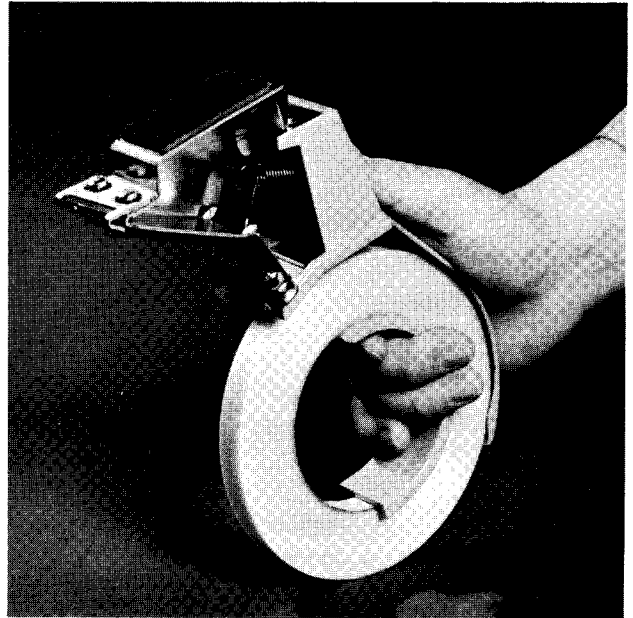

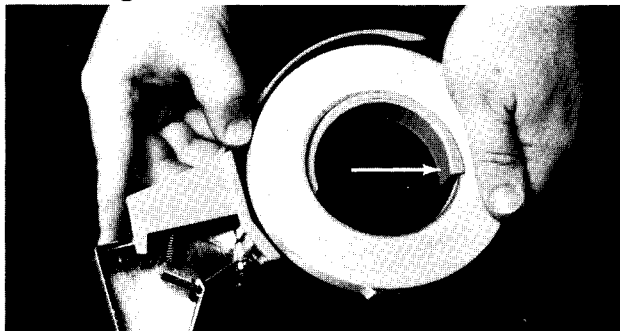

**Tape Length Dispensed:** Applied tape length when used as directed: "L" Clip Tape Application —  
Initial leg length: 2-1/4 ± 1/4 inches [57 ± 6 mm].  
Final leg length: approximately 2-1/4 inches or 55 mm.

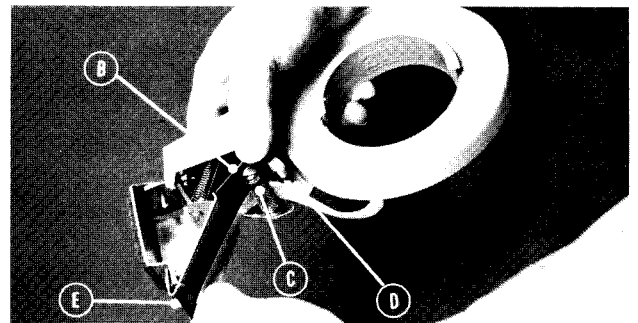


H-131 One-Hand Filament Tape Applicator, Model 27300.

### Loading Instructions

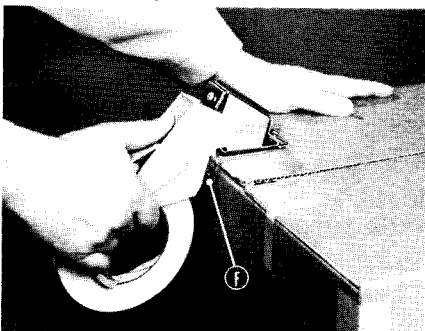


**Figure 1** — Lift up on brake (A), start roll over back edge of H-131 tape roll grip as shown by arrow. Push tape roll forward and press down to fully mount tape roll.



**Figure 2** — Pull 4 - 6 inches or 100 - 150 mm of tape from the roll, hold the tension arm (B) open and thread the tape over the knurled roller (C) as shown. Apply tension to the brake to hold the roll, pull the tape forward to snap the tape into the guide slot (D). Release the tension arm, and turn back the roll so the tape lead end is even with the cut off blade (E) and the tape is flat on the buff pad. Dispenser is ready to use.

### Operating Instructions



**Figure 3** — "L" Clip Application — Bring the H-131 with tape down onto the top flap so the ski (F) is squarely against the side of the box as shown. Pull the H-131 straight forward, pressing downward to buff the tape to the box.



**Figure 4** — Pull the H-131 over the box edge to dispense about 2 inches [50 mm] of tape as shown. Apply tension on the brake, tilt the H-131 upward, and tack the tape to the side of the box with the top buff pad to form a tight seal.



**Figure 5** — With brake tension on the tape roll, push the H-131 straight downward to cut the tape and buff it against the box to complete the application.

## How To Replace The Blade

**WARNING** – Use care when working near the blade as blade is extremely sharp.

1. Loosen, but do not remove screws to remove used blade.
2. Install replacement blade with beveled cutting edge toward tape roll.
3. Seat blade on screws and center on blade clamp.
4. Tighten mounting to secure blade.

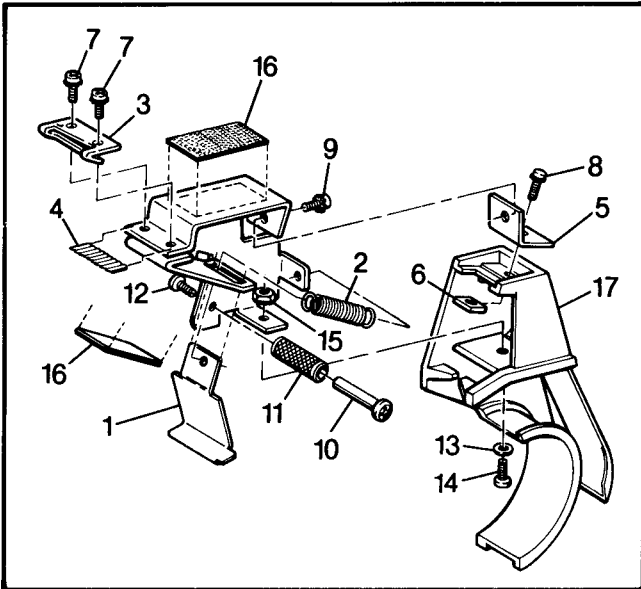


Figure 6 — Replacement Parts.

## Maintenance

**Lubrication** — Add one drop of SAE No. 20 oil to knurled roller shaft every 90 days.
